Welcome to use SmallRig All-in-One Video Kit Pro (2022). This kit is specially designed for vlogging and live-streaming. The kit includes a universal phone cage, and two side handles with wireless control, a quick release desktop tripod, etc. It supports both handheld shooting and tripod shooting and will effectively make the shooting more stable and convenient. It provides multiple 1/4"-20 thread holes and cold shoe mounts for more mounting options.

Note: the Kit does not include the mobile phone and charger.

Installation

- Mount the power bank holder on the back of the cage via two 1/4"-20 screws.
- Turn the knob on the top of the phone cage counterclockwise to open the phone holder. After putting the phone in, turn clockwise to lock.
- Mount the handle to the side of the cage via its 1/4"-20 screws.
- Please take off the quick release plate on the tripod and attach it to the downside of the cage, then mount the cage on the tripod.

Operation Guide

Wireless Control Module Name	SR WR-02
Power On	Press the camera button for 3 seconds to power on, it will flash for 4 seconds then enter into the paired status with indicator light flashes.
Power Off	Press the camera button for 3 seconds to turn off the power, and the indicator light will turn off.
Unpaired Status	Indicator light flashes.
Paired Connection Status	After pairing and connecting, the indicator light is off; Power off without operation for 20 minutes.
Standby Status	After powering on, in the status of no pairing connection, it will automatically shut down if there is no operation for 5 minutes.
Camera Button	Shortly press the camera button, the indicator light flashes, start shooting.
Charging Status	Plug in the charging cable, the red light is constantly on, until fully charged, the blue light is constantly on.
Working Status	When the battery level is $\geq 20\%$: indicator light is displayed in blue light.
	When the battery level is $< 20\%$: indicator light is displayed in red.
